There being no further speakers, Mayor Schwarz closed the Public Hearing at 8:02 p.m.

Mayor Schwarz re-opened the Public Hearing at 8:04 p.m. for further discussion and comment.

There being no further speakers, Mayor Schwarz closed the Public Hearing at 8:10 p.m.

Following deliberation and a question and answer period, the City Council directed staff to take a break to address the feasibility of the six proposed conditions in the David Moss & Associates, Inc. letter, dated May 5, 2011, addressed to Associate Planner Valerie Darbouze, as follows, including Item No. 7 regarding the consideration to plant tree(s) along the driveway, an item agreed upon between neighbors.

1. Prior to the start of construction the applicant will provide (i) a construction schedule, (ii) the name and contact information of the contractor(s), and (iii) a staging plan for construction vehicles, to neighbors along Renee and Laura La Plante Drives, and will post a sign on the property with an emergency – 24/7 contact number.

- 2. The applicant will cease noise generating construction if notified in advance by a neighbor with a short-term affair, i.e, a wedding or party that would otherwise be disrupted.
- *3. The applicant will notify neighbors in advance of any temporary disruption to any utility service.*
- 4. The applicant will voluntarily commit to a reduction of construction hours to 8 AM – 6 PM Mon- Sat.
- 5. The applicant will utilize street parking along Renee Drive consistent with the rights of any and all reciprocal access easements, and will avoid parking in locations along Renee Drive that create a restriction in the roadway that is demand by the Fire Department to create inadequate or unsafe passage for emergency vehicles.
- 6. The applicant will install cutouts for location of trash cans along the curbface of Rene Drive subject to approval by the City.
- 7. The applicant agrees to plant a tree on each side of the driveway of each lot.

The City Council recessed at 8:25 p.m. and reconvened at 8:57 p.m.

Planning Associate Valerie Darbouze reported back to the City Council regarding the seven proposed conditions, recommending Item Nos. 1, 3, 4, and 7 be maintained as conditions, as amended, and excluding Item Nos. 2, 5, and 6 as follows:

- 1. **Maintain as a condition**; with the addition that the language and format of the posted sign will be approved by City staff.
- 2. Not appropriate condition; covered by the construction schedule.
- 3. **Maintain as a condition**.
- 4. **Maintain as a condition**.
- 5. Not appropriate condition; private street and conditions are enforced by the Fire Department.
- 6. Not appropriate condition; private street and trash cans are temporary and regulated by the Agoura Hills Municipal Code, including specific requirements from the trash companies regarding accessing trash cans.
- 7. **Addition of condition**; applicant volunteered to plant trees on each side of the driveway, recommendation to plant a small tree.

Council also requested a condition be included regarding trash container cutouts, but left it up to the Director of Planning and Community Development to determine the feasibility.

- ACTION: Following further deliberation, the suggestion, due to potential privacy issues to the neighbors, to remove the proposed second story balcony or create an architectural feature only, was opposed 3-2 with Councilmember Koehler and Councilmember Edelston in favor.
- ACTION: Following discussion and a question and answer period, the motion by Mayor Pro Tem Kuperberg, to adopt <u>Resolution No. 11-1642</u> and <u>Resolution No. 11-1643</u>, including the proposed conditions, as amended, was seconded by Councilmember Weber and approved 5-0.

Assistant City Manager Hamburger presented an amended agreement for City Council consideration.

Following presentation of the staff report, Mayor Schwarz opened the floor for public comment.

Following discussion, Councilmember Edelston recommended the City Council approve the agreement with the proposed changes to Item Nos. 3 and 8, as referenced in bold below, with a further recommendation that legal counsel consider the changes for inclusion in any future agreement templates. 3. <u>PERFORMANCE</u>. Consultant shall at all times faithfully, competently and to the best of his or her ability consistent with industry standards, experience, and talent, perform all tasks described herein. Consultant shall employ, at a minimum, generally accepted standards and practices utilized by persons engaged in providing similar services as are required of Consultant hereunder in meeting its obligations under this Agreement.

8. <u>Indemnification, Hold Harmless, and Duty to Defend.</u>

- A. Indemnity for Design Professional Services. In connection with its design professional services, Consultant shall hold harmless and indemnify City, and its elected officials, officers, employees, servants, designated volunteers, and those City agents serving as independent contractors in the role of City officials (collectively, "Indemnitees"), with respect to any and all claims, demands, damages, liabilities, losses, costs or expenses, including reimbursement of attorneys' fees and costs of defense (collectively, "Claims" hereinafter), including but not limited to Claims relating to death or injury to any person and injury to any property, which arise out of, pertain to, or relate to in whole or in part to the negligence, recklessness, or willful misconduct <u>as determined by final arbitration or court decision or by the agreement of the parties</u>, of Consultant or any of its officers, employees, subcontractors, or agents in the performance of its design professional services under this Agreement.
- ACTION: Following discussion and a question and answer period, the motion by Councilmember Edelston, to approve the agreement, as amended, was seconded by Councilmember Koehler and approved 5-0.

CITY COUNCIL, STAFF COMMENTS

Councilmember Edelston noted that school was in session and wished everyone a good school year.

Mayor Schwarz reported he had the opportunity to present a certificate of recognition to Madelyn Perry, in recognition of her 105th birthday, and congratulated City Engineer Adeva on the birth of his daughter.
