SUBJECT: CONSIDERATION OF A NEGOTIATED JOINT TAX EXCHANGE

WITH THE COUNTY OF LOS ANGELES FOR ANNEXATION OF PARCEL MAP NOS. 65503 AND 69426 INTO COUNTY LIGHTING

**MAINTENANCE DISTRICT 10032** 

The areas shown of the attached City of Agoura Hills projects, Parcel Map Nos. 65503 and 69426, are being processed for annexation into the Los Angeles County Lighting Maintenance District 10032 and County Lighting District LLA-1, (Agoura Hills Zone), in order to provide funds for the operation and maintenance of street lights. Since these areas are within the boundaries of the City of Agoura Hills, an approved resolution is required, granting consent and jurisdiction to the County of Los Angeles to accomplish this annexation.

Annexation of street lighting systems into a lighting and maintenance district is a routine procedure. The annexation will allow the expenditure of maintenance district funds for the upkeep and operation of street lights in these areas.

## RECOMMENDATION

Staff recommends that the City Council:

- 1. Approve Resolution No. 11-1647 granting consent and jurisdiction to the County of Los Angeles in the matter of County Lighting Maintenance District 10032 and County Lighting District LLA-1, Agoura Hills Zone, for City of Agoura Hills Projects, Parcel Map Nos. 65503 and 69426.
- 2. Approve Joint Jurisdiction Transfer Resolution Nos. 11-1648, & 11-1649, for the above-referenced projects.


- A RESOLUTION OF THE CITY OF AGOURA HILLS, CALIFORNIA, GRANTING CONSENT AND JURISDICTION TO THE COUNTY OF LOS ANGELES IN THE MATTER OF COUNTY LIGHTING MAINTENANCE DISTRICT 10032 AND COUNTY LIGHTING DISTRICT LLA-1, AGOURA HILLS ZONE PROJECTS PARCEL MAP NOS. 65503 AND 69426
- **WHEREAS,** the Board of Supervisors of the County of Los Angeles is about to commence proceedings under Divisions 7 and 15 of the Streets and Highways Code for the annexation of territory to County Light Maintenance District 10032 and County Light District LLA-1, Agoura Hills Zone; and
- **WHEREAS,** street lights will be installed or were installed in the proposed annexation territories located in the City of Agoura Hills; and
- **WHEREAS,** all of the land included in the proposed annexation is located within the boundaries of the City of Agoura Hills.
- **NOW, THEREFORE, BE IT RESOLVED,** by the City Council of the City of Agoura Hills, as follows:
- **SECTION 1.** That the public interest, convenience, and necessity require the maintenance of a street lighting system located within said territories as shown on the maps of the proposed annexation areas to County Lighting Maintenance District 10032 and County Lighting District LLA-1, Agoura Hills Zone, attached and on file in the office of the County of Los Angeles Department of Public Works.
- **SECTION 2.** That this City Council hereby consents to the annexation of said territories, as shown on the attached maps, included within the boundaries of said annexation and lying within the boundaries of the City of Agoura Hills. See attached site maps and Property Tax Transfer Resolution Worksheets.
- **SECTION 3.** That this City Council hereby finds and determines that the land included within the boundaries of the proposed annexations and located within the boundaries of the City of Agoura Hills will be benefited by the proposed annexation and hereby consents to the inclusion of said land within the proposed annexation and to the assessment thereof.
- **SECTION 4.** That the consent of the City Council of the City of Agoura Hills is hereby given to the commencement of the proceedings for said annexation to County Lighting Maintenance District 10032 and County Lighting District LLA-1, Agoura Hills Zone, the Board of Supervisors over all proceedings necessary thereto for the purpose of consummating the same, all in accordance with the provisions of Divisions 7 and 15 of the Streets and Highways Code.



WHEREAS, pursuant to Section 99.01 of the California Revenue and Taxation Code, prior to the effective date of any jurisdictional change that will result in a special district providing one or more services to an area where those services have not previously been provided by any local agency, the special district and each local agency that receives an apportionment of property tax revenue from the area must negotiate an exchange of property tax increment generated in the area subject to the jurisdictional change and attributable to those local agencies; and

WHEREAS, the Board of Supervisors of the County of Los Angeles, acting on behalf of the County Lighting Maintenance District 10032; the Los Angeles County General Fund; the Los Angeles County Library; the Consolidated Fire Protection District of Los Angeles County; the Los Angeles County Flood Control Drainage Improvement District; the Los Angeles County Flood Control District; the Board of Trustees of the Los Angeles County West Vector Control District; the Board of Directors of the Resource Conservation District of the Santa Monica Mountains; the City Council of the City of Agoura Hills; the Board of Directors of the Las Virgenes Municipal Water District; and the Board of Directors of the Las Virgenes Municipal Water Improvement District No. 15 have determined that the amount of property tax revenue to be exchanged between their respective agencies as a result of the annexation proposal identified as Parcel Map No. 69426 to County Lighting Maintenance District 10032 is as shown on the attached Property Tax Transfer Resolution Worksheet.

## NOW, THEREFORE, BE IT RESOLVED, AS FOLLOWS:

1. The negotiated exchange of property tax revenues between the County Lighting Maintenance District 10032; the Los Angeles County General Fund; the Los Angeles County Library; the Consolidated Fire Protection District of Los Angeles County; the Los Angeles County Flood Control Drainage Improvement District; the Los Angeles County Flood Control District; the Board of Trustees of the Los Angeles County West Vector Control District; the Board of Directors of the Resource Conservation District of the Santa Monica Mountains; the City Council of the City of Agoura Hills; the Board of Directors of the Las Virgenes Municipal Water District; the Board of Directors of the Las Virgenes Municipal Water

Improvement District No. 15, resulting from annexation of Parcel Map No. 69426 to County Lighting Maintenance District 10032 is approve and accepted.


- 2. For annexation projects within the City of Agoura Hills Community Redevelopment Project Area, County Lighting Maintenance District 10032 will not receive the negotiated share of the annual tax increment until such time as the affected redevelopment project area is terminated for purposes of receiving an annual tax increment.
- 3. For fiscal years commencing on or after July 1, 2011, or the July 1 after the effective date of this jurisdictional change, whichever is later, the property tax revenue increment generated from the area within Parcel Map No. 69426 (Tax Rate Area 12536), shall be allocated to the affected agencies as indicated in the enclosed Property Tax Transfer Resolution Worksheet.
- 4. No transfer of property tax revenues other than those specified in Paragraph 2 shall be made as a result of annexation of Parcel Map No. 69426
- 5. If at any time, after the effective date of this resolution the calculations used herein to determine initial property tax transfers or the data used to perform those calculations are found to be incorrect, thus producing an improper or inaccurate property tax transfer, the property tax transfer shall be recalculated and the corrected transfer shall be implemented for the next fiscal year, and any amount of property tax received in excess of that which is proper shall be refunded to the appropriate agency.


