SIDEWALK EASEMENT DEDICATION AT 28700 CONEJO VIEW

DRIVE

As a condition for improvements to the Annandale club house located at 28700 Conejo View Drive, the applicant was required to construct a new parking stall and driveway approach in order to be compliant with the Americans with Disabilities Act (ADA).

Subsequently, the existing sidewalk path of travel becomes non-ADA compliant as a result of the new driveway approach. In order to achieve complete compliance, the Annandale Homeowners Association is proposing to re-route a small portion of the sidewalk onto their property. As shown on the attached exhibit, a five-foot sidewalk easement would be dedicated to the City. Any future maintenance would be the responsibility of the City, but there will be no cost incurred for acquiring this easement.

With Council approval of Resolution 12-1662, the acceptance of the sidewalk easement will ensure safe pedestrian access along this street.

## RECOMMENDATION

Staff respectfully recommends approval of Resolution number 12-1662; accepting a sidewalk easement dedication at 28700 Conejo View Drive.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF AGOURA HILLS, CALIFORNIA, ACCEPTING A SIDEWALK EASEMENT DEDICATION AT 28700 CONEJO VIEW DRIVE
