SUBJECT: ADOPT RESOLUTION NO. 12-1667, APPROVING THE INSTALLATION OF 25 FEET OF RED CURB TO RESTRICT PARKING ON CASPIAN COURT

Public safety concerns have recently been expressed regarding vehicles that have been parking along a curved portion of street, south of the residential driveway located at 30409 Caspian Court (see attached). The parked vehicles on the west side could potentially obstruct the visibility of motorists driving around this section of the street.

In light of this, the City's Traffic Engineer recommends the installation of approximately 25 feet of red curb, along the curve on the west side of the street. This will ensure that parked cars are not obstructing the views of motorists in both directions, and that the safety of drivers is protected in this area.

With City Council approval, red curb would be installed by the City's Public Works Contractor within a couple weeks. In addition, the Lost Hills Sheriff's Traffic Division will be notified of the changes, allowing for immediate enforcement of the new restrictions.

RECOMMENDATION

Staff respectfully recommends the City Council adopt Resolution No. 12-1667, approving the installation of 25 feet of red curb to restrict parking on Caspian Court.

RESOLUTION NO. 12-1667

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF AGOURA HILLS, CALIFORNIA, APPROVING THE INSTALLATION OF 25 FEET OF RED CURB TO RESTRICT PARKING ON CASPIAN COURT

WHEREAS, public safety concerns have been expressed for the need to establish a parking policy that prohibits parked vehicles from creating line-of-sight problems; and,

WHEREAS, Section 22507 of the California Vehicle Code permits local authorities to restrict parking on streets under their jurisdiction; and,

WHEREAS, the City's Traffic Engineer has determined there is a line-of-site problem at the curve south of the driveway located at 30409 Caspian Court, and thus, a need to restrict vehicles from parking any time along this portion of roadway to maintain clear line-of-sight; and,

WHEREAS, the City's Traffic Engineer is recommending that 25 feet of red curb be installed along the west side of the street located at the curve south of 30409 Caspian Court to maintain line-of-sight; and,

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Agoura Hills adopts Resolution No. 12-1667, establishing parking restrictions on Caspian Court by installing 25 feet of red curbing.
