INTERSECTION TRAFFIC SIGNAL LIGHTING AND INTERNALLY

The City contracted with Traffic Development Services, Inc. to retrofit existing intersection traffic signal lighting and internally illuminated street name signs with new LED lighting. There are a total of fourteen (14) signalized intersections within the City and all but one of the signalized intersections was retrofitted with LED lighting. By replacing traffic signal lighting and illuminated street name signs with new LED lighting, the City will remain consistent with the Energy Commission's standard for LED technology. The project will allow the City to further reduce its energy consumption at signalized intersections, ultimately helping us meet our goal of reducing energy and environmental impacts citywide.

ILLUMINATED STREET NAME SIGNS PROJECT; NIB 11-02

The total cost of the work was \$74,837.22, which included one (1) change order. The change order included the elimination of the intersection at Liberty Canyon Road and Agoura Road to keep the project within budget of the remaining grant funds available. The additional items under the change order involved repairing and troubleshooting the existing wiring to provide power to the new LED lighting. The project was completed within budget. The work was performed to the satisfaction of staff and is expected to serve the City well.

RECOMMENDATION

Staff respectfully recommends the City Council:

- 1. Approve, and accept as complete, the work of Traffic Development Services, Inc. for the LED Retrofit of Intersection Traffic Signal Lighting and Internally Illuminated Street Name Signs Project; NIB 11-02.
- 2. Authorize the Public Works Director/City Engineer to sign the Notice of Completion for the project, and authorize the City Clerk to forward the Notice of Completion to the County recorder for recordation.
- 3. Authorize the Public Works Director/City Engineer to release the retention amount 35 days after the Notice of Completion is recorded.
