# FY 2006-07 BUDGET WORKSHOP

### **APPROVAL OF AGENDA**

On a motion by Councilmember/Agency Member Schwarz, second by Councilmember/Agency Member Koehler, the Agenda was approved without objection.

#### **DISCUSSION**

1. Discussion of Proposed FY 2006-2007 City and Redevelopment Agency Budget

Assistant to the City Manager Nathan Hamburger provided an overview of the budget, including the proposed changes, noting that the Volunteers on Patrol Program in the Sheriff's Department would be brought back for Council consideration on June 28, 2006.

Councilmember/Agency Vice Chair Edelston suggested that it would be helpful in the budget process to incorporate the consideration of the proposed projects in the Five-Year Capital Improvement Plan prior to review and approval of the annual budget.

The City Council/Redevelopment Agency concurred with the Finance Committee's recommendation to set aside funding from the General Fund reserve balance toward the Reyes Adobe Road Bridge Widening Project.

Mayor/Agency Member Weber requested staff formalize a policy on newsracks throughout the City.

Following discussion and a question and answer period, the Community Outreach Grant Program Requests for FY 2006-07 were unanimously approved by the City Council, in the amount of \$20,500, as follows:

After further discussion, the City Council, by consensus, directed staff to bring back, before the next Community Outreach Grant process, recommendations on suggested parameters for the program including: whether or not to form a community-based committee to review the grant applications; create a budget for the grant program; establish criteria on how the various groups would be funded; whether or not to place a limitation on the amount of times an organization can annually be funded; and whether or not there should be an annual cap, plus a percentage (i.e.; 10% of the budget), on the total amount of funds available for the annual grant distribution.

ACTION:

Following presentation of the staff report and a question and answer period, the motion by Councilmember/Agency Vice Chair Edelston to approve the draft budget, as presented and recommended by the Finance Committee and to bring back the final budget for a public hearing and adoption on June 28, 2006, was seconded by Councilmember/Agency Member Schwarz and approved 5-0.
