SUBJECT: CONTRACT AWARD FOR AGOURA ROAD WIDENING PROJECT -

PHASE 1 CANWOOD STREET IMPROVEMENTS; NIB 13-01

On January 23, 2013, City Council authorized staff to seek bids for the Agoura Road Widening Project – Phase I Canwood Street Improvements; NIB 13-01. The Agoura Road Widening Project (Project) encompasses improvements for the ultimate build-out of Agoura Road, which includes the Agoura Village Specific Plan area, and reconstruction of Canwood Street, between Reyes Adobe Road and approximately 1050 feet east of Forest Cove Lane. Construction of the project will be completed in phases. The first phase is construction of the Canwood Street Improvements. The second phase is construction of the Agoura Road Widening improvements.

Recycle and Rubberized Asphalt Overlay, and slope stabilization of the south side of Canwood Street, from Forest Cove to just east of Strawberry Hill. Slope stabilization of Canwood Street includes installation of soldier piles along the south side of the street, under existing sidewalk, which will require reconstruction of curb, gutter and sidewalk. Additionally, various areas of Canwood, including the south side of Canwood, from Forest Cove to just east of Strawberry Hill, will require Full-Depth Pavement Reconstruction, which will include installation of new road base and asphalt pavement. And, finally, the Project will include street widening of Canwood, just east of the Fire Station, providing new curb, gutter, sidewalk and travel lane.

On February 26, 2013, the City received seven (7) sealed bids for the Project. The bid results were as follows:

Staff reviewed the bid submittal of the apparent low bidder, Sully Miller Contracting Company, and deemed their bid responsive and acceptable. Sully Miller Contracting Company provided references to several cities and all were in good standing. Construction services provided to referenced cities included Cold In-Place Recycling, pavement overlay, street widening, pavement restoration and concrete work.

The Agoura Road Widening Project is included as part of the Los Angeles County Metropolitan Transportation Authority's (Metro) Long Range Transportation Plan (LRTP), which was approved by the Metro Board on October 29, 2009, and is guaranteed funding as part of Metro's priority list for the projects funded within the first ten years by Measure R. Construction is anticipated to start in April, and once started the project is anticipated to take approximately eight (8) weeks, with no work to be done on holidays.

RECOMMENDATION

Staff respectfully recommends the City Council:

- 1. Award the contract for the Agoura Road Widening Project Phase 1 Canwood Street Improvements; NIB 13-01 to Sully Miller Contracting Company; and
- 2. Authorize the Mayor to sign the contract agreement.
