(The applicant initially requested a parking variance from Municipal Code Section 9654.6. to allow a personal training gymnasium to locate in a light-industrial center with 52 total on-site parking spaces, instead of the required 64 parking spaces for all existing and proposed uses, but staff has determined that the variance is not required due to the prior approval of a parking variance for the same site.)
