PUBLIC HEARING

6. Open and Conduct a Public Hearing on the Consideration and Adoption of Resolutions of Necessity for the Acquisition in Eminent Domain of Certain Real Property for Public Purposes, namely the fourteen (14) properties listed below, in connection with the Agoura Road Widening and Canwood Street Improvements Project

City Clerk Rodrigues announced that this was the time and place set for a Public Hearing to consider thirteen (13) Resolutions of Necessity Nos.: 13-1723 through 13-1735 (Resolution No. 13-1722 was pulled), and to let the record show that the notice of this hearing was provided as required law. The records and files of the City and the staff report concerning this matter shall be entered into the record by reference.

At 6:09 p.m., Mayor Weber opened the Public Hearing on the adoption of the proposed Resolutions of Necessity.

Assistant City Manager Hamburger provided the evidence stated and referred to in the Report to Council.

If the City Council finds, based upon the evidence contained and referred to in the Report to City Council, the testimony and comments received at this hearing, and all written testimony submitted to the City Council, that the evidence warrants the necessary findings with respect to each of the proposed Resolutions of Necessity, then staff recommends that the City Council, in the exercise of its discretion, adopt proposed Resolution Nos. 13-1723; 13-1724; 13-1725; 13-1726; 13-1727; 13-1728; 13-1729; 13-1730; 13-1731; 13-1732 13-1733; 13-1734; and 13-1735 (each of which requires a 4/5ths vote of the entire Council) and authorize the City Attorney's office to file eminent domain proceedings to acquire each of the following real property interests:

Eminent Domain Attorney Danner provided a summary of the following four necessary findings for each separate resolution:

- a. The public interest and necessity require the Proposed Project;
- b. The Proposed Project is planned and located in the manner that will be most compatible with the greatest public good and least private injury;
- c. The Subject Property Interests described in each Resolution of Necessity are necessary for the Proposed Project; and
- d. The City has made an offer as required by Government Code section 7267.2 to each of the owners of record of the real property it seeks to acquire.

Following presentation of the staff report and summary of necessary findings, Mayor Weber opened the floor for testimony from any person wishing to be heard on issues a, b, c, and d above.

"Good evening Mayor Weber, Members of Council and Staff. I did submit a letter with some exhibits which, I would ask, be made a part of the record for this hearing in order to preserve my client's rights in the event that the City does not approve a global settlement. I do want to thank you, Council, for authorizing staff to work with my two clients over the last year towards this global settlement and I look forward to seeing that on your agenda soon. In the event that doesn't go forward, I did list a number of objections. And, I don't really want to take up any more of your time, I am available for questions, but thank you."

Brian Tucker, Agoura Hills, representing Gateway Church, regarding Parcel 24, 29646 Agoura Road, Agoura Hills, California, also identified as Assessor's Parcel Number 2061-033-013.

"Good evening Mayor Weber, Councilmembers and staff, my name's Brian Tucker, speaking on behalf of Gateway Church. which is a landowner of Parcel 24 at 29646 Agoura Road, affected by the resolutions under consideration. The Church's Pastor, Brian Campbell, was called out of town. He sends his regard and asked me to speak on his behalf as a member of the Church Counsel. Gateway appreciates all that the City does for our community and our intention always is to engage with the City in the task of community building. So, it's in the spirit of that common goal that we're constructively engaging in this land use process. And, I just have three observations. First, as you may know, the City and our church have, in the past, engaged in conversations for the purchase, by the City, of church land. While those discussions aimed at a different use, in our view, the valuation reflected in correspondence during that process is, we think, quite relevant to the current process. That valuation was twenty-seven dollars a square foot. My second observation is that the proposed project would prevent our members from turning left out of our lower parking lot. One remedy for this partial loss of use is to connect the lower parking lot with our main parking lot by bridging the stream course that separates them. In any event, we encourage the City to take this left turn issue into consideration for our church property in this process. And, lastly, the proposed project would remove a monument, which is an important symbol of our faith tradition that stands in a prominent place on the property. We'll need to move that monument or erect a similar monument at a different location and we request the City's support for that requirement. Thank you."

There being no further public speakers or testimony, Mayor Weber closed the Public Hearing at 6:17 p.m.
