SUBJECT: ADOPT RESOLUTION NO. 13-1737; A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF AGOURA HILLS, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON NOVEMBER 5, 2013, DECLARING THE RESULT THEREOF AND SUCH OTHER MATTERS AS PROVIDED BY LAW

The County of Los Angeles Registrar-Recorder/County Clerk has certified the results of the City of Agoura Hills General Municipal Election held on November 5, 2013, and provided the Official Certificate of the Canvass of the Election Returns and the Official Statement of Votes Cast for the City of Agoura Hills (Exhibit A).

The results of the canvass of the votes cast for member of the City Council has determined that Denis Weber (1,445), Harry Schwarz (1,246), and William D. Koehler (1,226) are the elected and qualified members of the City Council.

RECOMMENDATION

Adopt Resolution No. 13-1737, confirming the official canvass of the election returns for the November 5, 2013, General Municipal Election.

RESOLUTION NO. 13-1737

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF AGOURA HILLS, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON NOVEMBER 5, 2013, DECLARING THE RESULT THEREOF AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a General Municipal Election was held and conducted in the City of Agoura Hills, California, on Tuesday, November 5, 2013, as required by law; and

WHEREAS, a notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, pursuant to the City Council's request and delegation of authority through Resolution Nos. 13-1703, 13-1704, and 13-1705, adopted on June 12, 2013, the County of Los Angeles Registrar-Recorder/County Clerk, Election Coordination Section, canvassed the returns of the election and has certified the results to this City Council. Said certifications are received, attached, and made a part, hereof, as "Exhibit A".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF AGOURA HILLS, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the whole number of ballots cast in the precincts, including any provisional ballots and excluding vote-by-mail-ballots, was 1164.

That the whole number of vote-by-mail ballots cast in the City, including any provisional vote-by-mail ballots, was 1360, for a grand total of 2524 ballots cast in the City of Agoura Hills.

SECTION 2. That the five (5) names of the persons voted for in the election for Member of the City Council were as follows:

Nominated/Certified Candidates:	Chris Anstead
	William D. Koehler
	Meril S. Platzer
	Harry Schwarz
	Denis Weber

SECTION 3. That the number of votes given at each precinct and the number of votes given in the City, to each of the persons above named for the respective offices for which the persons were candidates, was as listed in Exhibit "A" attached.

SECTION 4. That the City Council does declare and determine that: Denis Weber (1,445) was elected as Member of the City Council for the full term of four years; Harry Schwarz (1,246) was elected as Member of the City Council for the full term of four years; and William D. Koehler (1,226) was elected as Member of the City Council for the full term of four years.

SECTION 5. That the City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing: (1) The whole number of ballots cast in the City; (2) The names of the persons voted for; (3) For what office each person was voted for; (4) The number of votes given at each precinct to each person; and (5) The total number of votes given to each person.

SECTION 6. That the City Clerk shall immediately make and deliver, to each of the persons so elected, a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also cause to be administered, to each person elected, the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the Office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

SECTION 7. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
