INTERGOVERNMENTAL, SPECIAL PURPOSE COMMITTEE, & DEPARTMENTAL REPORTS

Mayor Koehler made the following important announcement:

"This evening, the City of Agoura Hills is pleased to announce that Los Angeles County Supervisor Zev Yaroslavsky has informed the City of a \$250,000 grant towards the new Agoura Hills Recreation Center. Through Supervisor Yaroslavsky's generosity and continuous support of Agoura Hills, the City will now have the funding to construct the new interpretive play area. This playground is an exciting aspect of the project - it is going to provide a state-of-the-art, progressive play area that will include an underground slide, rock wall, and fun animal climbing features. It's an area that will also provide opportunities for lots of collaborative and intergenerational programming. On behalf of the City of Agoura Hills, and the entire Agoura Hills community, I would like to thank Supervisor With this financial contribution, Agoura Hills Recreation Yaroslavsky. Center will truly be the heart of this community. I'd also like to thank our staff for their diligent work, as well as members of the City Council that assisted in this effort."

Mayor Koehler reported that a month ago, he, along with Councilmember Edelston and City Manager Ramirez, had met with Supervisor Yaroslavsky regarding this opportunity, and expressed his pleasure that Supervisor Yaroslavsky decided to award the grant to the City of Agoura Hills.

Councilmember Edelston expressed appreciation to staff, noting that one of the reasons the City was awarded the grant was attributable to the amount of preparation that went into the presentation, to Supervisor Yaroslavsky and his staff, that demonstrated the need and use of the grant funds; and shared that Supervisor Yaroslavsky had relayed that it was one of the best presentations he had received.

Mayor Pro Tem Buckley Weber noted a previous grant had been awarded through the Supervisor's Office and City Manager Ramirez confirmed that the City had also received a grant for the development of a trailhead at the new Recreation Center property.

CITY COUNCIL, STAFF COMMENTS

Mayor Pro Tem Buckley Weber reported that she attended the Santa Monica Mountains Conservancy meeting; noted the Advisory Committee had authorized a \$200,000 Prop 40 Fund Grant to MCRA, for project planning and design related to developing an environmental review for a wildlife crossing structure at 101/Liberty Canyon, and also supported a grant to the Nature Conservancy, for the purchase of open space in the Simi Hills, an area where there is a wildlife crossing area; stated "It's a great time for wildlife in our Santa Monica region and it's very exciting"; announced the City of Calabasas would be hosting an educational forum, entitled "Learn How to Protect Your Pet and Wildlife from Anticoagulant Rodenticides, More Commonly Known as Rat Poison," at the Calabasas Library Founders Hall on March 13, 2014, from 6-8:00 p.m., and invited everyone to attend.

Councilmember Schwarz announced the upcoming memorial for Dave Brown at the King Gillette Ranch on March 1, 2014, at 9:30 a.m., and requested everyone save the

date of June 21, 2014, as the Las Virgenes Homeowners Federation would be hosting a special event to honor Supervisor Zev Yaroslavsky.

Councilmember Edelston wished Director of Planning and Community Development Mike Kamino a quick recovery.

Councilmember Weber reported that he attended the Las Virgenes/Malibu Council of Governments meeting and a presentation by the Las Virgenes Municipal Water District (LVMWD) on water/drought issues; noted that LVMWD would be providing cities with a video that can be televised on local cable; and stated that he hoped everyone would have the chance to view the video and conserve water when they can.

Councilmember Schwarz spoke about the controversy surrounding e-cigarettes and vapors and requested the City address this issue at some future date.
