**REPAIR PROJECT; NIB 09-03** 

For the past five years, the City has contracted with FS Construction to repair damaged concrete throughout the City which included: lifted sidewalks, and broken curbs and gutters. In addition, they have replaced damaged asphalt with concrete bus pads at various MTA bus stop locations. This fiscal year's work has been completed, which included the installation of five (5) bus pads located on Agoura Road and Roadside Drive. The total cost of the work was \$49,240.00, which was within the budgeted amount of \$50,000.

The work was performed to the satisfaction of staff and is expected to serve the community well for many years to come.

### RECOMMENDATION

Staff respectfully recommends the City Council:

- 1. Approve and accept as complete, the work of FS Construction for the FY 2013-14 Annual Concrete Repair Project; NIB 09-03.
- 2. Authorize the Director of Public Works/City Engineer to sign the Notice of Completion for the project and authorize the City Clerk to forward the Notice of Completion to the County recorder for recordation.
