SUBJECT: ADOPT RESOLUTION NO. 15-1792, REQUESTING THE BOARD OF

SUPERVISORS OF LOS ANGELES COUNTY TO ACCEPT, ON BEHALF OF THE LOS ANGELES FLOOD CONTROL DISTRICT, THE TRANSFER AND CONVEYANCE OF STORM DRAIN IMPROVEMENTS

FOR MISCELLANEOUS TRANSFER DRAIN NO. 1596

The City of Agoura Hills is in the process of transferring the easements and maintenance responsibilities for the storm drain known as Miscellaneous Transfer Drain (MTD) No. 1596, to the Los Angeles County Flood Control District (LACFCD). The storm drain was constructed as part of the Riopharm/Williams Homes project (98-CUP-007), and consists of two drains and a debris basin located in the southwest portion of the project area.

In order to complete the transfer of the maintenance responsibilities, the City Council must adopt the attached resolution, and quitclaim the necessary easements to the LACFCD. Once the resolution and quitclaim documents have been approved and signed, they will be forwarded to the County for action by the Los Angeles County Board of Supervisors. All fees for the inspection, repair, and transfer of the drain have been paid to the County by the developer.

RECOMMENDATION

Staff respectfully recommends that the City Council:

- 1. Approve Resolution No. 15-1792, requesting the transfer and conveyance and improvements of storm drain known as MTD No. 1596 (Tract Maps 48312 & 48901) to the Los Angeles County Flood Control District.
- 2. Authorize the Mayor to sign the resolution requesting transfer.
- 3. Authorize the Mayor to sign the quitclaim of easements.
- Direct the City Clerk to attest and record resolution and quitclaim easements, and send a certified copy of the resolution to the Los Angeles County Flood Control District.

RESOLUTION NO. 15-1792

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF AGOURA HILLS, CALIFORNIA, REQUESTING THE BOARD OF SUPERVISORS OF THE LOS ANGELES COUNTY FLOOD CONTROL DISTRICT OF THE STATE OF CALIFORNIA TO ACCEPT, ON BEHALF OF SAID DISTRICT, THE TRANSFER AND CONVEYANCE OF THE STORM DRAIN IMPROVEMENTS KNOWN AS MISCELLANEOUS TRANSFER DRAIN NO. 1596 IN THE CITY OF AGOURA HILLS FOR FUTURE OPERATION, MAINTENANCE, REPAIR, AND IMPROVEMENT, AND AUTHORIZE THE TRANSFER AND CONVEYANCE THEREOF

THE CITY COUNCIL OF THE CITY OF AGOURA HILLS HEREBY FINDS, RESOLVES, AND ORDERS AS FOLLOWS:

WHEREAS, there have been dedicated to, or the City of Agoura Hills has otherwise acquired, the storm drain improvements and drainage system known as Miscellaneous Transfer Drain (MTD) No. 1596, depicted on Los Angeles County Flood Control District Drawing No's 420-F4.1-.9 on file with the Director of Public Works for the County Los Angeles; and

WHEREAS, the City is authorized and empowered to transfer and convey to the Los Angeles County Flood Control District (hereinafter referred to as District) any storm drain improvements and drainage systems for future operation, maintenance, repair, and improvement; and

WHEREAS, the City and the District entered into an Agreement dated December 27, 1983, and recorded April 17, 1984, as Document No. 84-462954, of the Official Records in the Registrar-Recorder/County Clerk's office, whereby the City made certain warranties about its future transfers and conveyances of flood control facilities to the District; and

WHEREAS, the best public interest will be served by transfer and conveyance of said storm drain improvements and drainage system from the City to the District for future operation, maintenance, repair, and improvement.

NOW, THEREFORE, BE IT RESOLVED, that the City does hereby request the District to accept the transfer and conveyance of the storm drain improvements and drainage system depicted on District Drawing Nos. 420-F4.1-.9 on file with the Director of Public Works for the County of Los Angeles.

BE IT FURTHER RESOLVED that, subject to the acceptance thereof of the Board of Supervisors of the District, the City Engineer is directed and ordered to prepare all necessary instruments and documents to effectuate the transfer and conveyance and that the Mayor is authorized and instructed to execute said documents and other instruments. The District shall have no obligation or responsibility to maintain the storm drain, improvements, and drainage until all rights of way for the drain now vested in the City and all other necessary rights of way have been conveyed to and accepted by the District.
