A point has been reached where, in the opinion of the City Council on the advice of its legal counsel, based on existing facts and circumstances, there is a significant exposure to litigation against the City regarding the Los Angeles Regional Water Quality Control Board's 2012 MS4 Permit. On June 16, 2015, the State Water Resources Control Board adopted a final order resolving the petitions for review of the 2012 Los Angeles MS4 Permit ("Permit"). Various environmental groups filed a petition for writ of mandate on June 24, 2015, in which they assert that parts of the Permit violate legal provisions of the federal

Clean Water Act. In addition, the City of Gardena filed a separate action on June 24, 2015 seeking to challenge other provisions of the Permit and naming the City and other LA-County based municipalities as real parties in interest.

The City Council, as a real party in interest, will consider authorizing the defense against the case brought to challenge the Permit (as modified by the final order), and whether to intervene or participate in other litigation in connection with the Permit.
