SUBJECT: APPROVAL OF THE DESIGNATION OF APPLICANT'S AGENTS

RESOLUTION FOR NON-STATE AGENCIES DESIGNATING THE CITY MANAGER, DEPUTY CITY MANAGER AND FINANCE DIRECTOR AS AUTHORIZED AGENTS FOR THE CITY OF AGOURA HILLS (CAL

EMA)

Under the Robert T. Stafford's Disaster Relief and Emergency Assistance Act of 1988, agencies are required to designate and authorize City Agents to execute, on behalf of the City, applications for assistance to obtain federal financial assistance and/or state assistance for various storm, flood, or other natural disasters. Cal EMA requires that all agencies continue to renew their Designation of Applicant's Agency Resolution, Cal EMA Form 130, with their offices every three years.

In the past, individuals were named on the designation form, however now Cal EMA allows titles only to be place in the resolution to allow the document to remain valid if an Authorized Agent leaves the position and is replaced by another individual. The time period for the last designation has expired and now requires a renewal. While the current expired designation will not result in the City not receiving federal or state assistance, it could delay assistance if the proper documentation is not present in their offices. The current resolution will be effective for all open and future disasters within the three years following approval.

Upon approval, City staff will forward the agent's resolution to the appropriate Cal EMA offices.

RECOMMENDATION

Staff respectfully recommends the City Council approve Designation of Applicant's Agent Resolution for Non-State Agencies, designating the City Manager, Deputy City Manager, and Finance Director as authorized agents for the City of Agoura Hills, and direct staff to forward the Cal EMA Form 130 Resolution to representatives at the California Emergency Management Agency offices...
