City Attorney Lee stated for the record that the City Council has not articulated any objection to this particular project. The City Council has simply called up the project to be given the opportunity to review the project as a whole. This is a reminder to the City Council, and just everyone, that the City Council will be reviewing this application "de novo", with fresh eyes, and is limited to the evidence in the record presented this evening when making its determination.

Mayor Schwarz disclosed that he had met with the applicant and reviewed the project, made no comments, but did review what the applicant had to say.

Mayor Pro Tem Weber disclosed that he had met with the applicant and City staff, was briefed on the history of the project and issues, made no comment to the project, and did not discuss the project with any Councilmembers.

Councilmember Northrup disclosed that she had met with the applicant and City staff, was briefed on the history and some of the land use issues, did not comment or express her views, did ask a question about the window coverings and if the applicant could provide information at this meeting on that topic, and did not discuss this project with any of her colleagues on the Council.

Councilmember Buckley Weber disclosed that she had met with the applicant and City staff, her comments to the applicant were limited to landscaping, she did not render any opinions or tell the applicant her feelings about the project, and she discussed some landscaping options.

Mayor Schwarz reopened the Public Hearing at 9:24 p.m. Following a question and answer period with the applicant, Mayor Schwarz closed the Public Hearing at 9:47 p.m.

Planning Director Hooper offered suggestions for language on the conditions of approval noting staff would return to Council with resolutions of approval reflecting the changes offered by the applicant including: 1) a reduction in the building height to 36.5 feet; 2) a reduction in the sign square footage of 75 sq. ft. on the north building elevation of Building A; 3) 113 sq. ft. on the south elevation; 4) the north building elevation sign would be halo lit; 5) a portion of the windows on the north elevation of Building A would be blacked out; including the addition of the following conditions:

- (1) "The Planning Department shall monitor for 30 days after the initial opening of the fitness business the light emitting from the north elevation windows of Building A and, if deemed necessary by the Planning Director, the business shall apply window tinting and/or draw interior window shades nightly to minimize impacts from interior lights on views from the freeway.";
- (2) "Interior lights facing the freeway, excluding security lights, shall be turned off upon close of business each day."
- (3) "Lighting for signage on the north elevation of Building A shall be turned off at the close of business each day."

(4) "The Landscape Plan shall be revised to incorporate: 1) additional green screens on the north elevation of Building A; and 2) additional landscaping material between the building and the access road adjacent to the freeway, with the intent to screen the building as viewed from the freeway corridor. If deemed necessary by the Planning Director, in consultation with the applicant, the sidewalk on the north side of Building A may be removed and replaced with a planter to meet the requirement of this condition. These revisions to the Landscape Plan shall be subject to prior approval by the Planning Director."

- 6) Oak Tree Permit Case No. 14-OTP-016
- 7) Sign Permit Case No. 14-SP-040
- 8) Additional Conditions of Approval, as stated by Planning Director Hooper
- 9) Revised Condition of Approval Number 128.
