



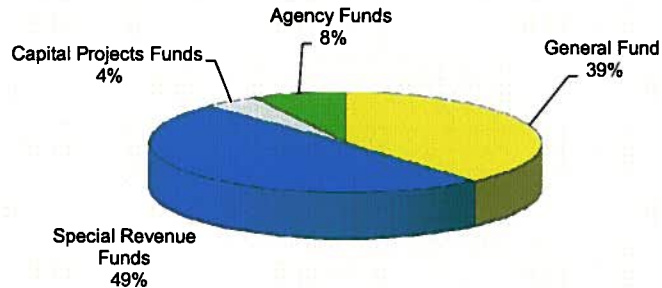


City Funds - Non-Bond Proceeds
