7. CONTINUED PUBLIC HEARING:

LOCATION: South side of Agoura Road, east of Calle Montecillo and

015)(018-020)(023-042); and 2061-015-008)

REQUESTS: A request for approval of Conditional Use Permits to allow

development on two recorded residential tracts for 27 detached, single-family residences (14 units and 13 units in each tract); request for approval of a Variance to allow one residence to be located 26 feet from the Agoura Road right-of-way, rather than at least 32 feet away; request for an Oak Tree Permit to remove 32 Oak trees and encroach within the protected zone of 19 oak trees; and a request for

adoption of a Mitigated Negative Declaration.

Tom Cohen, 2801 Townsgaste Rd. Suite 215 Thousand Oaks, representing the applicant, presented the case and answered questions of the Planning Commission.

Yair Koshet, 5226 Medina Rd. Woodland Hills, project architect for the applicant, presented the architectural design and answered questions of the Planning

Commission.

Yael Lir, 30 N. Raymond Ave. #814 Pasadena, Landscape Architect for the applicant, presented the landscape plan and

answered questions of the Planning Commission.

Don Waite, 100 N. Rancho Rd. Suite 2 Thousand Oaks, Civil

Engineer for the applicant, answered questions of the Planning Commission.

Kathy Patey, Envicom Corp. 28328 Agoura Road, environmental consultant for the applicant, spoke about the consultation between the applicant, Department of Fish and Game, Army Corps of Engineers and the Santa Monica Mountains Conservancy and answered questions of the Planning Commission.

Jon Irvine, 1461 E. Chevy Chase Dr. Glendale, Soil Engineer/Geologist for the applicant, answered questions of the Planning Commission.

Richard W. Campbell, Thousand Oaks, Landscape Architect and Oak Tree Consultant for the applicant, answered questions of the Planning Commission.

Joan Yacovone, 27328 Country Glen, expressed concerns with the project's pad elevation height, the size of the yards, parking, drainage, house size, geology, and the notification requirement for the project.

Rudy C'Dealva, 4062 Jim Bowie, President Liberty Canyon (Homeowners Association) commented on the impacts of dust, noise, and heavy equipment diesel exhaust. He was also concerned with the history of slope failures in the project area and he wanted to see additional community outreach for comments on the proposed project.

A.J. Ponsiglione, 4937 Calle Roblida, spoke in favor of the project. Mr. Ponsiglione spoke of the positive effect the project would have on the surrounding property values and was pleased with the addition of a new sidewalk.

Michael Petterson, 27802 Via Amistosa, spoke against the project as designed. Mr. Petterson expressed concern with the lack of proper neighborhood outreach, the loss of views from his property and the environmental impacts associated with the project.

Upon giving direction to staff to return with additional information concerning the project, Commissioner Schwarz moved to continue the public hearing to September 15, 2005. The motion was seconded by Vice Chair Ramuno. Motion carried 4-0. (Commissioner Zacuto was absent).
