COUNTY OF LOS ANGELES COUNTY CLERK

Fictitious Business Name/ Doing Business As (DBA):

Business owners wishing to use a fictitious name (other than his/her own full family name) for the business, must clear the name through the Los Angeles County Clerk to ensure that no one else is using it. Once cleared, the owner is required to print it in a newspaper of a specified circulation, in the area in which the business will be operating. DBA renewals take place every 5years.
