SUBJECT: LA-RICS - PROPOSED FACILITY INSTALLATION (KIMBERLY PEAK)

At its August 24, 2016 regular meeting, the City Council received a presentation from the Los Angeles Regional Interoperable Communications System (LA-RICS) staff concerning their proposed plans to proceed with its installation of communication equipment associated with its Land Mobile Radio (LMR) element of LA-RICS at Kimberly Peak.

The City Council was presented information on why the site was selected in response to the lack of LA-RICS communication coverage areas in this region, proposed equipment (70-foot monopole with microwave and antennas, etc.), and its site access agreement with the current property owner (Morrison Ranch Estates Homeowners Association). After some discussion, some members of the City Council expressed concerned over the full disclosure of the project to effected property owners near the proposed LA-RICS project who may not be fully aware of this endeavor.

The City Council provide comments to the LA-RICS staff concerning methods to attempt to minimize impacts, and ultimately determined that it would be best conduct another discussion on this project to afford potentially impacted residents the ability to learn more about the project and provide comments. Following direction from the City Council, City staff mailed 467 meeting notification letters to properties within a 2,000 foot radius of the area.


LA-RICS staff will be present to answer any questions by the City Council and/or the public.

Need for LMR


Existing Systems and Equipment
