## **NEW PUBLIC HEARING**

3. **REQUEST:** Request for the Planning Commission to recommend the City Council adopt an ordinance to: 1) amend Municipal Code Sections 9660-9660.4 to clarify that all commercial marijuana activity, both medical and non-medical, is prohibited in all zones of the City, and to allow limited indoor marijuana cultivation consistent with state law; 2) delete Municipal Code Section 4125 (“Compensation for medical marijuana”); and 3) make a finding of exemption under the California Environmental Quality Act.
