SUBJECT: CONTRACT AWARD FOR THE FY 2017-18 PAVEMENT REHABILITATION PROJECT; NIB 17-01

The Capital Improvement Program for Fiscal Year 2017-18 includes a joint project with the City of Westlake Village for the annual pavement rehabilitation project. On June 14, 2017, Council approved a joint street maintenance project agreement, which detailed how the two cities would pay for the work done in their respective cities. As per the agreement, the City of Westlake Village would oversee the bid advertising, bid award, and contract administration of the project, and each City would be responsible for the construction management of the project within their respective city limits.

Staff worked with the City Engineer of Westlake Village to prepare the plans and specifications, which consist of resurfacing approximately 2.5 miles of pavement using rubberized asphalt concrete (RAC). The use of RAC provides our City streets several advantages over conventional asphalt concrete, such as increased resistance to reflective cracking, providing a quieter ride, and better striping contrast; all while recycling used tires.

The proposed City streets for this year's project include:

- Acadia Avenue
- Agoura Road (Hydepark Drive to Liberty Canyon Road)
- Aquarius Avenue
- Canwood Street (28401 Canwood Street to the Flood Channel)
- Capricorn Avenue
- Cornell Road (Agoura Road to Cornell Way)
- Cornell Way (Kanan Road to City Limit)
- Lewis Road (Canwood Street to Driver Avenue)
- Marlies Street
- Sumac Park Parking Lot
- Tulare Lane
- Waring Place

The proposed project also includes removing and replacing nine (9) curb ramps in order to comply with current American with Disabilities Act (ADA) standards, as well as, slurry sealing the parking lots at Old Agoura Park and the City's Recreation and Event Center.

On July 20, 2017, the City of Westlake Village received six (6) sealed bids for the project. The bid results were as follows:

Staff reviewed the bid submittal of the apparent low bidder, C.A. Rasmussen, and deemed their bid responsive and acceptable. C.A. Rasmussen recently completed the City's Agoura Road Widening Project, with favorable results.

The City of Agoura Hills' portion of the work is estimated to be approximately \$776,000. By pursuing this joint project with Westlake Village, the unit costs for materials are typically reduced due to the large amount of material required to complete the work for both cities.

The FY 2017-18 budget includes \$300,000 of Proposition C funds, \$210,000 of Measure R (Local) funds, \$190,000 of Surface Transportation Program (STP-L) funds, \$119,844 of Senate Bill 1 (SB1) funds, \$5,000 from the General Fund, and a RAC grant in the amount of \$14,200, for a total project budget of \$839,044. Staff expects construction to commence in September, taking approximately thirty (30) days to complete, with no work to be done on holidays.

RECOMMENDATION

Staff respectfully recommends the City Council support the awarding of the contract for the FY 2017-18 Pavement Rehabilitation Project; NIB 17-01, to C.A. Rasmussen in the amount of \$1,996,351.35.
