## **NEW PUBLIC HEARING**

REQUEST:

Request for the Planning Commission to recommend the City Council adopt an ordinance to: 1) amend Municipal Code Sections 9660-9660.4 to clarify that all commercial marijuana activity, both medical and non-medical, is prohibited in all zones of the City, and to allow limited indoor marijuana cultivation consistent with state law; 2) delete Municipal Code Section 4125 ("Compensation for medical marijuana"); and 3) make a finding of exemption under the California Environmental Quality Act.

Commissioner Anderson moved to approve Zoning Ordinance Amendment Case No. ZOA-01326-2017, and adopt Resolution No. 17-1195; A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF AGOURA HILLS, CALIFORNIA, RECOMMENDING THE CITY COUNCIL ADOPT AN ORDINANCE, AMENDING MARIJUANA **DISPENSARIES** DIVISION 10 (MEDICAL OF PART 2 (SPECIAL REGULATIONS) OF PROHIBITED) CHAPTER 6 (REGULATORY PROVISIONS) ARTICLE IX (ZONING) OF THE AGOURA HILLS MUNICIPAL CODE TO CLARIFY THAT ALL COMMERCIAL MARIJUANA ACTIVITY IS PROHIBITED IN ALL ZONES IN THE CITY, AND TO ALLOW LIMITED INDOOR MARIJUANA CULTIVATION CONSISTENT WITH STATE LAW, AND DELETING SECTION 4126 (COMPENSATION FOR MEDICAL MARIJUANA) OF THE AGOURA HILLS MUNICIPAL CODE, AND MAKING A FINDING OF EXEMPTION FROM CEQA UNDER SECTION 15061(b)(3) OF THE CEQA GUIDELINES (CASE NO. ZOA-01326-2017), including the ordinance revisions, as submitted by Assistant City Attorney Marroquin, and the following amendments to the proposed Ordinance: 1) under Section 9660(3)(B), replace the word "allow" with the word "permit", and 2) throughout the draft Ordinance, anywhere that a specific statutory code is mentioned, add the phrase "as the same may be amended time to time" where it is not otherwise in the proposed Ordinance. ### PLANNING COMMISSION/STAFF COMMENTS

Commissioner Anderson noted that state law restricts marijuana smoking in child care centers and schools, but not in private residences, and expressed her concern with smoking of marijuana in licensed family child care centers. Assistant City Attorney Marroquin noted that marijuana smoking is prohibited anywhere that tobacco smoking is prohibited, including all enclosed places of employment.
