5. Discussion Regarding Story Pole Procedures and Consideration to Adopt Resolution No. 18-1862; A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF AGOURA HILLS, CALIFORNIA, ADOPTING STORY POLE PROCEDURES FOR VARIOUS TYPES OF DEVELOPMENT PROJECTS

Following deliberation by the City Council, modifications were made to the Story Pole Procedures based on City Council approval, and as recommended by the City Attorney as follows, to accurately reflect the intent of the City Council:

Applicability

Story poles shall be installed by the applicant for development projects that require a discretionary permit or other entitlement that must be approved by the Planning Commission and/or City Council and meet one of the following criteria:

- 1) All projects in the Agoura Village Specific Plan area;
- 2) All new commercial, office, industrial, multi-family or mixed-use projects on vacant lots;
- 3) All new commercial, office, industrial, multi-family or mixed-use projects either:

 (a) requiring a building height or yard/setback Variance; (b) requesting an increase in the height of an existing building; or (c) requesting an increase in the footprint of an existing building;
- 4) All new commercial, office, industrial, multi-family or mixed-use projects on hillside lots (10% or greater average topographic slope);
- 5) All **new** commercial, office, industrial, multi-family or mixed-use projects on lots with unique topographic features (e.g., knoll, creek, significant oak tree cover, etc.), as determined by the Planning Director; or
- 6) All new single-family residential projects requiring a building height or yard/setback Variance, at the discretion of the Planning Director.

Waiver from Story Pole Installation

The Planning Director is authorized to consider a <u>request for a</u> waiver <u>of</u> or <u>a</u> <u>modify modification to</u> the story pole requirement for particular projects <u>in the following very limited circumstances:</u>

<u>1)</u> The Planning Director <u>will only may</u> grant a waiver request <u>only</u> if the <u>story pole</u> installation poses a health or safety risk; <u>or</u>

2) The Planning Director may modify the length of time the story poles must remain on a property or if unique site constraints exist, impact the extent or duration of the installation, and upon and in the case of such modification, the applicant shall be subject to conditions of approval as determined by the Planning Director.

The Planning Director's decision on a **story pole** waiver **or modification** request is final.
