The second Development Project Forum shall be held within thirty (30) days after the City Development Review Committee (DRC) has met and the applicant has received City comments, but prior to the application being deemed complete. <u>Development applications</u> (that are subject to these Guidelines) that have already been submitted to the City but have not yet been deemed complete as of May 9, 2018 shall be required to conduct one Development Project Public Forum and shall follow the requirements applicable to Second Development Project Public Forums as set forth in these Guidelines.

Notification for the Second Development Project Public Forum

The second Development Project Public Forum shall be noticed at least 21 10 14 days prior to the date of the forum, and mailed by the applicant to the following:
