SUBJECT: ADOPT RESOLUTION NO. 18-1887; AMENDING THE COMPENSATION PLAN BY INCREASING THE RANGE OF THE RECREATION LEADER I. INSTRUCTOR, ADMINISTRATIVE INTERN I, RECREATION LEADER II, OFFICE ASSISTANT. ADMINISTRATIVE INTERN II. SENIOR PROGRAM INSTRUCTOR, AND RECREATION SPECIALIST IN COMPLIANCE WITH THE 2019 CALIFORNIA MINIMUM WAGE INCREASE TO \$12.00

PER HOUR

On January 1, 2019, the California Minimum Wage will increase to \$12.00 per hour. In order to insure compliance, the City is required to increase the ranges of two of our parttime/temporary classifications: Recreation Leader I and Instructor, which currently start at \$11.12 per hour, and in order to maintain a similar percentage separation between related classifications, the ranges of Administrative Intern I, Recreation Leader II, Office Assistant, Administrative Intern II, Senior Program Instructor, and Recreation Specialist will need to be increased effective December 29, 2018.

All of the affected salary range increases were considered and included as part of the 2018-2019 budget adoption, and no further appropriations are required. The part-time position of Special Event Worker remains unaffected by the new minimum wage law.

RECOMMENDATION

Staff recommends the City Council adopt Resolution No. 18-1887, amending the compensation plan by increasing the range of the Recreation Leader I, Instructor, Administrative Intern I, Recreation Leader II, Office Assistant, Administrative Intern II, Senior Program Instructor, and Recreation Specialist in compliance with the 2019 California Minimum wage increase to \$12.00 per hour, effective December 29, 2018.
