On September 26, 2018, the City Council awarded the Fiscal Year 2018-19 Annual Concrete Repair Project; NIB 18-05(1), to FS Contractors, Inc., in the amount of \$72,769.25. The scope of work consisted of repairing lifted sidewalks, broken curbs and gutters, and constructing one (1) ramp within the City.

FS Contractors Inc., completed the project ahead of the approved schedule, with no change orders being issued. The work was performed to the satisfaction of staff, and is expected to serve the community well for many years to come.

RECOMMENDATION

Staff respectfully recommends the City Council:

- 1. Approve, and accept as complete, the work of FS Contractors, Inc., for the Fiscal Year 2018-19 Annual Concrete Repair Project; NIB 18-05(1); and
- 2. Authorize the City Engineer to sign the Notice of Completion for the project, and authorize the City Clerk to forward the Notice of Completion to the County Recorder for recordation.
