Location, situation and surrounding area traffic patterns not comparable to proposed project. Staff study does not include evaluation of actual traffic volume, etc. as compared with applicant's proposed project (using internal projections re volume, time frames and patron movement patterns).

Limited entry-exit pattern, more controlled movement pattern than proposed project, an no 'competing' traffic movement adjacent to tenant-oriented parking area..

Staff report does not include information on traffic/parking v. increased seating (indoor/outdoor).



Isolated pad, with single tenant.

Driveways well-isolated from tenant parking.

No need for pedestrian cross-over through planters.

Internal driveway wider and with more maneuvering space than proposed project = minimizing possibility of impacts caused by extra queuing.

Internal driveway with adequate space for 3-point turn at terminus, if spaces are all occupied.

We are completely opposed to the proposed drive-thru at Starbucks on Kanan Rd. This is NOT an appropriate site for a drive-thru!

This plan will further increase and exacerbate the already existing traffic nightmare as cars enter and exit the driveways off Kanan, as well as further congest the passageway behind Starbucks and Yum Yum Donuts. People already use this pass thru driveway to bypass the traffic on Kanan when they are in a hurry, or to go to the driveway by Agoura Deli to make a left turn going north onto Kanan. The increase in emissions from idling cars will add to the already polluted air at that intersection, and will surely impact the town homes directly across the street. An eyesore will be created by the oncoming cars facing the south bound traffic. Building a wall to hide the cars will only be uglier!

I saw the removal of a magnificent giant old oak tree in order to build the store that now stands empty next to the Wells Fargo Bank in that very shopping center. And next door, the ancient oak died that stood in front of the Maral Cuisine restaurant, encroached upon on both sides by concrete, asphalt and parked cars.
