SUBJECT: CONTRACT AWARD FOR THE FISCAL YEAR 2019-20 PAVEMENT

**REHABILITATION (SLURRY SEAL) PROJECT; NIB 19-01** 

On May 22, 2019, the City Council authorized staff to seek bids for the Fiscal Year 2019-20 Pavement Rehabilitation (Slurry Seal) Project; NIB 19-01. The scope of work consists of resurfacing residential streets with Type II rubberized asphalt concrete slurry seal, removing and replacing damaged asphalt in localized areas, and re-striping asneeded.

The proposed street sections include:

- Argos Street
- Bee Court
- Chelsea Court
- Conejo View Drive
- Dovetail Drive
- Eagleton Street
- Freshwater Drive
- Hackers Lane
- Hollow Oak Drive
- Indian Ridge Drive
- Kimberly Drive
- Lake Lindero Drive (between Thousand Oaks Blvd. and Reyes Adobe Rd.)
- Lake Nadine Drive
- Ridgeway Drive
- Saddlebrook Drive
- Sandtrap Drive
- Shady Creek Drive
- Stonecrest Drive (between Reyes Adobe Rd. and Rainbow View Dr.)
- Wheelhouse Lane
- Woodcreek Drive

On June 13, 2019, the City of Agoura Hills received four (4) electronic bids for the project. The bid results were as follows:

Pavement Coatings Co.	\$335,828.00
All American Asphalt	\$360,832.02
American Asphalt South, Inc.	\$363,317.00
Roy Allan Slurry Seal, Inc.	\$430,389.24

Staff reviewed the bid submittal of the apparent low bidder, Pavement Coatings Co., and deemed their bid responsive and acceptable. In 2017, Pavement Coatings Co. worked as a sub-contractor on the City's pavement resurfacing project and completed their portion of work with favorable results.

The proposed Fiscal Year 2019-20 project budget includes \$345,555 of Road Rehab Funds (SB1), pending the adoption of the Fiscal Year 2019-20 Budget by the City Council. Staff expects construction to commence in July, taking approximately forty-five (45) days to complete, with no work to be done on holidays.

## RECOMMENDATION

Staff respectfully recommends the City Council award the Fiscal Year 2019-20 Pavement Rehabilitation (Slurry Seal) Project; NIB 19-01, to Pavement Coatings Co. in the amount of \$335,828.
