APPROVAL OF THE DESIGNATION OF SUBRECIPENT'S AGENT RESOLUTION FOR HAZARD MITIGATION GRANT PROGRAM AND PRE-DISASTER MITIGATION PROGRAM DESIGNATING THE CITY MANAGER OR ASSISTANT CITY MANAGER, DEPUTY CITY MANAGER, DIRECTOR OF PUBLIC WORKS OR DIRECTOR OF FINANCE AS AUTHORIZED AGENTS FOR THE CITY OF AGOURA HILLS - CALIFORNIA OFFICE OF EMERGENCY SERVICES (CAL OES)

As a result of the Presidential Disaster Proclamation in connection with the Woolsey Fire, Hazard Mitigation Grant Program funding is available for agencies eligible to participate. The State of California Governor's Office of Emergency Services (Cal OES) requires that agencies submit their Designation of Sub-Recipient's Agent Resolution, Cal OES Form 130, with their offices. The form identifies City representatives authorized to submit appropriate applications, documents, on the City's behalf. The resolution identifies the following City positions: City Manager or Assistant City Manager, Deputy City Manager, Director of Public Works or Director of Finance.

The current resolution will be effective for all open and future disasters within the three years following approval. Upon approval, City staff will forward the resolution to the appropriate Cal OES office.

RECOMMENDATION

Staff respectfully recommends the City Council approve the Designation of Sub-Recipient's Agent Resolution for Hazard Mitigation Grant Program and Pre-Disaster Mitigation Program designating the City Manager or Assistant City Manager, Deputy City Manager, Director of Public Works or Director of Finance as authorized agents for the City of Agoura Hills, and direct staff to forward the Cal OES Form 130 resolution to representatives at the California Office of Emergency Services office.
