City Attorney Lee referred to a revised Donation Agreement on the dais and noted that, prior to the meeting, Creekside Terrace's attorney had requested a few minor revisions regarding dates in Sections 3.3 and 4.3 and the certificate of acceptance, regarding extending the escrow period. Accordingly, the inspection date will also be changed to January and the certificate of acceptance date will be changed once escrow closes. In addition, the Quitclaim Deed will be amended to reflect some limitations on use, as requested by Creekside Terrace, and she recommended the City Council authorize those changes and authorize the City Manager to work with the City Attorney's office and Creekside Terrace's attorney on the changes to the Quitclaim Deed.
