RESOLUTION NO. 05-1357, GRANTING CONSENT AND JURISDICTION TO THE COUNTY OF LOS ANGELES IN THE MATTER OF COUNTY LIGHTING MAINTENANCE DISTRICT 10032 AND COUNTY LIGHTING DISTRICT LLA-1, AGOURA HILLS ZONE PROJECTS TRACT NO. 34274, TRACT NO. 37246, L110-8, AND PARCEL MAP NO. 12051

WHEREAS, the Board of Supervisors of the County of Los Angeles is about to commence proceedings under Divisions 7 and 15 of the Streets and Highways Code for the annexation of territory to County Light Maintenance District 10032 and County Light District LLA-1, Agoura Hills Zone; and

WHEREAS, street lights will be installed or were installed in the proposed annexation territories located in the City of Agoura Hills; and

WHEREAS, all of the land included in the proposed annexation is located within the boundaries of the City of Agoura Hills.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Agoura Hills, as follows:

SECTION 1. That the public interest, convenience, and necessity require the maintenance of a street lighting system located within said territories as shown on the maps of the proposed annexation areas to County Lighting Maintenance District 10032 and County Lighting District LLA-1, Agoura Hills Zone, attached and on file in the office of the County of Los Angeles Department of Public Works.

SECTION 2. That this City Council hereby consents to the annexation of said territories, as shown on the attached maps, included within the boundaries of said annexation and lying within the boundaries of the City of Agoura Hills. See attached site maps, Exhibits A1-A4.

SECTION 3. That this City Council hereby finds and determines that the land included within the boundaries of the proposed annexations and located within the boundaries of the City of Agoura Hills will be benefited by the proposed annexation and hereby consents to the inclusion of said land within the proposed annexation and to the assessment thereof.

SECTION 4. That the consent of the City Council of the City of Agoura Hills is hereby given to the commencement of the proceedings for said annexation to County Lighting Maintenance District 10032 and County Lighting District LLA-01, Agoura Hills Zone, by the jurisdiction of said Board of Supervisors over all proceedings necessary thereto for the purpose of consummating the same, all in accordance with the provisions of Divisions 7 and 15 of the Streets and Highways Code.

SECTION 5. That the Clerk of the City Council is hereby directed to certify and deliver two copies of this Resolution to the County of Los Angeles Department of Public Works.

SECTION 6. The City Clerk shall certify to the passage of this Resolution by the City Council of the City of Agoura Hills and shall cause the same to be posted in three (3) conspicuous places in the City of Agoura Hills, and it shall thereupon take effect.
