The purpose of the Public Hearing is for the Planning Commission to receive information on updating the California Environmental Quality Act (CEQA) Transportation Thresholds of Significance pursuant to Senate Bill 743. State of California statutorily mandates that cities adopt Vehicle Miles Traveled (VMT) in place of Level of Service (LOS) as the metric for determining level of significance for CEQA by July 1, 2020.

PUBLIC PARTICIPATION: All interested parties are cordially invited to participate in this public hearing either by submitting written public comments by email or participating live by telephone. your public testimony. Public testimony is limited to three (3) minutes per speaker. A speaker's time may not be transferred to another speaker.

PLEASE TAKE NOTICE THAT State law requires the City to inform you that if you challenge the decision on this matter in court, you may be limited to raising only those issues you or someone else raised at the Public Hearing described in this Notice, or in written correspondence delivered to the Reviewing Body at or prior to the Public Hearing.
