#### **DISCUSSION / ACTION**

10. Discussion on Amendment to Emergency Eviction Moratorium

Following presentation of the staff report, Mayor Buckley Weber opened the floor for public comments.

Public comments were received by email and forwarded to the City Council prior to the meeting from the following person(s):

Monty Morton, General Manager of the Agoura Hills City Mall Bill Tucker, Owner of Whizin Market Square

Mayor Buckley Weber and Mayor Pro Tem Weber disclosed they had spoken by telephone with Mr. Morton and Mr. Tucker. Councilmember Lopez disclosed that she had spoken by telephone with Mr. Tucker.

MOTION: Councilmember Northrup moved to "extend the moratorium on evictions for residential and commercial to June 30, with a discussion about the item at the June 24 Council meeting; continue to keep the payback period at six months without any changes from what we have done before, subject to further discussion at the June 24 meeting with the potential for discussion of this longer period for residential after staff has had a chance to do some further research and report back."

City Attorney Lee recommended that, given that things are changing on a daily basis, to give her office and staff the latitude to come back with additional recommendations, as there might be some developments between now and the end of June that the City Council may wish to consider.

- ACTION: Councilmember Northrup "amended the motion that staff do research, along with the City Attorney's Office, and bring back any recommendations on this issue that they feel we should consider in our June meeting with respect to the status of eviction moratoriums, payback periods, or any other related issues." Mayor Pro Tem Weber seconded. The motion carried 5-0, by the following roll call vote:
  - AYES: Mayor Buckley Weber, Mayor Pro Tem Weber, and Councilmembers Anstead, Lopez, and Northrup.
  - NOES: None.

City Attorney Lee clarified that the action was to give staff direction to bring back an item for consideration and approval at the next City Council meeting in two weeks, May 27, 2020.

### COUNCIL, STAFF COMMENTS

Councilmember Northrup thanked residents for trying to keep up with the rules, regulations, and edicts from so many different government agencies, and encouraged everyone to continue to be kind to one another.

Councilmember Lopez spoke about: the reopening of local parks in the area; the Clean Power Alliance (CPA) offering a relief fund and assistance programs, working with Southern California Edison (SCE), to assist with extending or reducing electric bills; and the Los Angeles County Department of Public Health publishing new orders and she encouraged residents to patronize local businesses that can reopen.

Councilmember Anstead thanked residents and encouraged everyone to be safe about enjoying the outdoors and practice social distancing.

Mayor Buckley Weber reported on: COVID-19 and although the "curve has flattened" in Los Angeles County, the numbers continue to increase; shared that Dr. Barbara Ferrer recommended the number one protocol to follow is physical distancing; and, encouraged everyone to continue to wear face coverings.
