



## PUBLIC NOTICE

The Los Angeles County Local Agency Formation Commission (LAFCO) is preparing a Municipal Service Review (MSR), including for the City of Agoura Hills. The MSR documents and analyzes the public services of a city, and is a precursor to updating and reviewing a city's Sphere of Influence (SOI), which is a plan for the probable physical boundaries and services of a city. The SOI is the likely boundary of the city in the future, and may include territories the city plans to annex into its jurisdictional boundaries.

A Draft MSR is being prepared by LAFCO and its consultant, Policy Consulting Associates (PSA), and will be made available to the public for comment in mid-July 2020 on the following MSR and SOI Update website:

At the regularly scheduled meeting at **6:00 PM on Wednesday, July 22, 2020 via video conference (in-person attendance will not be permitted)**, LAFCO's consultant will make a presentation to the City Council on the Draft MSR and SOI Update recommendations. This is a discussion item only. Since the MSR and SOI Update recommendations are LAFCO documents, they will be considered by the LAFCO Commission at a publicly noticed meeting at a later date.
