My husband and I purchased our home in 1990 at 28617 Acacia Glen Street for \$50,000 more than the same model in other locations in Fountainwood. We paid a premium because of the unobstructed view from the back of the property and from the deck on the second story master bedroom which faced the one story next door (28623 Acacia Glen St) which was below the view line. We are now in the process of rebuilding our home, which was destroyed in the Woolsey Fire, along with the two homes next door below our house on Acacia Glen. We are complying with all previous building codes and putting the house on the same footprint with the understanding that we will again return to the same unobstructed views when construction is complete.

Almost all of the owner occupants in the Acacia Glen cul de sac have lived there a minimum of two decades, and oppose the building of a two story house on the lot at 28623 Acacia Glen St which is designated for a one story home: Diane Huddleston, Viveka and John O'Malley, Robert Sexton, the Mellmans and the Greenberg/Talleys.

After living through the trauma of the Woolsey fire which destroyed a third of our cul de sac, our goal is to return the homes to similar houses which occupied the now open lots.

Fountainwood is my forever neighborhood, and I would like to see its character remain intact, staying with the original intent and design of the beautiful homes and families that have owned and resided here for many decades and family generations.
