Enclosed are my concerns regarding the plans for the proposed building at 28623 Acacia Glen Street.

Realtors like to claim that Acacia Glen Street is the nicest street in Fountainwood and I would tend to agree—and the comps seem to confirm this. Hence, we are all interested in this project.

I would like to see story poling. The front of this house is closer to the street than any of the neighbors—some garages are that close but not the actual houses. It also looks like it will be taller than any of the neighbors houses. In short, it looks like they tried to compress as much house into the front of the lot as possible. Aesthetically, I don't think this is the best use for this property. Furthermore, this architectural plan is not consistent with the unique example of 1970s suburban architectural tract homes that we see in Fountainwood—that is, it does not conform to current design schemes of the neighborhood. The new house at 28617 uses it space in a much more appealing way—further off the street and not as high and not as boxy--and a design that is consistent with Fountainwood architecture. I don't think there is anything wrong with 2400 feet but the plans in the blueprints do not look like a good fit for the neighborhood.

I think it is in the best interest of the owner to come up with new blueprints. Mr. Woo, one of the neighbors, who is also rebuilding, shared his plans for his rebuild with ten families. The plans were very nice and everyone was on board. While I agree that he/she should be able to build the structure they want if it meets the city specifications and it is does not create negative externalities on the neighbor's property value—but I'm afraid with this design it might just do that.
