 Discussion Regarding the Los Angeles County Local Agency Formation Commission (LAFCO) Draft Municipal Service Review and Sphere of Influence Update

Jennifer Stephenson, Principal, Policy Consulting Associates, provided the staff presentation.

Following presentation of the staff report, Mayor Buckley Weber opened the floor for public comments.

Mayor Buckley Weber suggested bringing back the final comment letter to the full City Council for review at the regular meeting of August 26, 2020.

Discussion to Consider the Adoption of Resolution No. 20-1954; A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF AGOURA HILLS, CALIFORNIA, REVISING THE DIRECTOR OF EMERGENCY SERVICES' EXECUTIVE ORDER 2020-01 IMPOSING EMERGENCY REGULATIONS RELATED TO RESIDENTIAL AND COMMERCIAL TENANT EVICTIONS TO EXTEND THE EXPIRATION OF THE TENANT EVICTION MORATORIUM PERIOD AND TO ENCOURAGE LANDLORDS AND TENANTS TO AGREE TO A RENT REPAYMENT PLAN

Councilmember Northrup moved to adopt Resolution No. 20-1954, as amended, "that extends the moratorium to the September date (September 30, 2020) that has been adopted by the County, and revising the language, per the discussion of Council, to encourage repayment, but not to set terms, and ask staff to give a report at the August meeting (August 26, 2020) on the issues that the Council has discussed." ## COUNCIL, STAFF COMMENTS

Councilmember Anstead encouraged residents to wear their masks and practice safe distancing; to keep their spirits up, enjoy themselves outside, and spend time with their families; and to anticipate new therapies and a vaccine in the next 3-6 months.

Councilmember Lopez spoke about the doubling of the current (COVID-19) cases, reporting that 57% of new cases are in people under 41 years-old; thanked staff for patrolling parks and open spaces to ensure that people that are not from within the same household are not congregating; spoke about restaurants that have applied for and enacted outdoor dining permits and urged everyone to patronize them; and announced the City's new website address will be agourabillscity.org.

Councilmember Northup acknowledged these were challenging times and spoke about the importance of connecting "to show people that you care about them and accept people caring about you," noting the City Council and staff cared so much about the people they serve; encouraged everyone to contact the City with their concerns; and urged everyone to continue to wear a mask.

Mayor Pro Tem Weber encouraged the youth to make the commitment to not only keep themselves safe, but the people around them safe, and wished everyone to stay safe, healthy, and happy.

Mayor Buckley Weber reminded everyone that we do not know the long-term effects for those stricken by COVID-19 and to remind young people to stay healthy for both themselves and their families; encouraged everyone to "hang in there and keep moving forward" and that the community was going to get through this; asked residents to support local businesses; spoke about the increase in confirmed cases in Agoura Hills and the surrounding areas; urged everyone to be diligent and practice social distancing, stay within their family pod, and wear a face covering; and to be especially mindful of wearing a face covering when patronizing businesses.
