Councilmember Reinhardt commended staff on the first Summer Concert in the Park held at Chumash Park on June 19, reported that he attended a meeting of the Las Virgenes Homeowners Association regarding a Total Maximum Daily Load (TMDL) discussion; and announced that the Regional Water Quality Control Board has scheduled a hearing, related to the TMDL issue, for September 1, 2005 at City Hall.
