SUBJECT: ADOPT RESOLUTION NO. 21-1964 RATIFYING ADDITIONAL WORK

COMPLETED TO PROVIDE ASPHALT CONCRETE CRACK SEALANT TREATMENT AND AUTHORIZING THE CITY MANAGER TO EXECUTE CONTRACT AMENDMENT TO RUBBERIZED CRACKFILLER SEALANT, INC. TO MEMORIALIZE ADDITIONAL WORK ASSOCIATED

WITH CRACK SEALING TREATMENT

This report seeks City Council adoption of Resolution No. 21-1964 ratifying additional work completed for the asphalt concrete crack treatment of the streets impacted by the Morrison Ranch Gas Mainline Replacement Project (Project) and authorizing the City Manager to execute contract amendment to memorialize additional work associated with the agreement between Rubberized Crackfiller Sealant, Inc. and the City.

Under Southern California Gas Company's (SoCalGas) Distribution Integrity Management Program (DIMP), SoCalGas routinely perform various pipeline maintenance and safety tasks, including patrolling, inspecting, testing, repairing and replacing pipelines, and upgrading their infrastructure. SoCalGas scheduled the Project as part of their DIMP and completed construction of the Project in phases which impacted several streets in the Morrison Ranch neighborhood: Belmont Court, Green Meadow Drive, Middle Crest Drive, Ridgebrook Drive, Rolling Ridge Drive, Stonecrest Drive, Walford Court and Woodglen Drive. During construction, SoCalGas added Adelina Court to their Project scope.

Construction of the Project required that several pavement cuts be made into these roadways for the upgrade of the gas main line and service laterals. The City issued an encroachment permit for the Project, requiring SoCalGas to apply a slurry seal treatment on the surface of all impacted streets after the Project was completed in order to reduce the likelihood of water penetrating any cuts to the roadways surface. The value of the slurry seal improvements performed and paid for by SoCalGas is estimated to be \$86,000.

A slurry seal is a preventative maintenance treatment that helps protect streets from water penetration, improves a street's aesthetic after significant trenching is completed, and can be performed to extend the life of a roadway. When slurry seal is used to extend a roadway's lifetime, streets are prepared with an application of asphalt concrete crack sealant prior to the seal.

Budget for this effort was included within the Annual Citywide Street Improvement Project as part of the FY 20-21 Capital Improvement Program. On September 14, 2020, the City Manager executed an Agreement for Contractor Services with Rubberized Crackfiller Sealant, Inc. (RCS) for an amount not to exceed \$25,000. A Notice to Proceed was issued to RCS to start crack sealing on December 21, 2020.

When budgeting the project in April 2020, staff estimated length of cracks to be sealed was approximately 20,700 linear feet. When the work commenced on December 21, 2020, RCS removed vegetation and air blasted the cracks which were to be filled. Upon exposing the cracks in the field, linear footage of cracks were measured once more and it was determined the required footage for crack sealing was 26,123. This increase in footage relates directly to an increased cost of the operation.

In order to limit the impact to the residents during the holiday season, and avoid additional mobilization and traffic control costs, approval for RCS to complete the additional crack sealing was provided during construction. The work was completed on December 22, 2020. The additional crack sealing services require a contract amendment in the amount of \$4,727.01, with this single amendment the final contract amount will be \$29,727.01. Adequate budget remains in the Annual Citywide Street Improvement Project to allow for this increase.

RECOMMENDATION

Staff recommends the City Council to adopt Resolution No. 21-1964 ratifying additional work completed for the asphalt concrete crack treatment of the streets impacted by the Morrison Ranch Gas Mainline Replacement Project and authorizing the City Manager to execute a contract amendment for the additional work performed in association with an Agreement for Contractor Services with Rubberized Crackfiller Sealant, Inc.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF AGOURA HILLS, CALIFORNIA, RATIFYING ADDITIONAL WORK COMPLETED TO PROVIDE ASPHALT CONCRETE CRACK SEALANT TREATMENT AND AUTHORIZING THE CITY MANAGER TO EXECUTE CONTRACT AMENDMENT TO RUBBERIZED CRACKFILLER SEALANT, INC. TO MEMORIALIZE ADDITIONAL WORK ASSOCIATED WITH CRACK SEALING TREATMENT

THE CITY COUNCIL OF THE CITY OF AGOURA HILLS HEREBY FINDS, RESOLVES, AND ORDERS, AS FOLLOWS:

- **WHEREAS**, SoCalGas routinely performs rehabilitation and upgrading of their infrastructure under their Distribution Integrity Management Program (DIMP); and
- **WHEREAS**, the Morrison Ranch Gas Mainline Replacement Project (Project) was identified as part of SoCalGas' DIMP; and
- **WHEREAS**, SoCalGas agreed to include slurry seal treatment to all roadways affected by the Project; and
- **WHEREAS**, the City of Agoura Hills (City) added crack sealing of the Project area to help extend the life of the roadways as part of the City's Capital Improvement Program; and
- **WHEREAS**, the City and Rubberized Crackfiller Sealant, Inc. (RCS) entered into an Administrative Agreement for Contractor Services for the construction of crack sealing of the impacted roadways of the Project for an amount not to exceed \$25,000; and
- WHEREAS, during construction additional roadway cracks required sealing and RCS was provided a notice to proceed for additional crack sealing was issued to keep the project moving to completed construction; and
- **WHEREAS**, a final amendment to the Rubberized Crackfiller Sealant, Inc. Administrative Agreement for Contractor Services to memorialize the additional costs in the amount of \$4,727.01 is necessary; and
- NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF AGOURA HILLS DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:
- **Section 1.** The City Council of the City of Agoura Hills, California, hereby adopts Resolution 21-1964, ratifying additional work completed for the asphalt concrete crack treatment of the streets impacted by the Morrison Ranch Gas Line Replacement Project
