Councilmember Anstead moved to: 1) receive and file the report for the solid waste rate escalation increase (2.14%) for residential solid waste services for 2020, and 2) approve the additional solid waste rate adjustment request submitted by Waste Management. 12. Discussion and Direction Regarding the Agoura Hills/Calabasas Community Center (AHCCC) Update

Following presentation of the staff report, Mayor Weber opened the floor for public comments.

There were no public speakers.

Director of Community Services Brink summarized the City Council discussion and direction to staff as follows: 1) the City Council, unanimously, is not in favor of employing a consultant for the project; 2) the City Council is not in favor of creating a specific task force, as there are existing committees already in place that have been meeting regularly to review and discuss the current state of the AHCCC; 3) the City Council is in favor of a meeting with the City of Calabasas to increase communication and strengthen collaborations; 4) the City Council is in favor of

putting the roof repair, accompanied by a reopening plan, for financial consideration in the City's budget process in February; and 5) the City Council is in favor of staff setting up a City Council subcommittee meeting in January for the February presentation.

ACTION:

Mayor Pro Tem Lopez moved to "submit our comments to staff, which include not supporting a consultant, continuing with our committee and communication process with our own subcommittee and with Calabasas, and deferring discussion on roof and other maintenance until the February budget discussion with the Finance (sub) Committee" Councilmember Buckley Weber seconded. The motion carried 5-0, by the following roll call vote:

COUNCIL, STAFF COMMENTS
