"Section II. The Project has been reviewed pursuant to the California Environmental Quality Act (CEQA), and has been determined to be exempt from CEQA per Section 15303(c) Section 15061(b)(3). The Project does not have the potential for causing any significant effect on the environment, because it consists of the allowance of alcohol use on the premises of a restaurant. The use is contained within an approved building, and the use does not modify the approved development or physical environment. No exception to this determination applies as set forth in Section 15300.2 of the CEQA Guidelines, including, but not limited to, subsection (c), which relates to unusual circumstances that could have a significant effect on the environment."
