SUBJECT: APPROVE FIRST AMENDMENT TO AGREEMENT FOR CONSULTANT

SERVICES WITH RRM DESIGN GROUP FOR ADDITIONAL MEETINGS
OF THE AGOURA VILLAGE SPECIFIC PLAN CITIZENS ADVISORY

**GROUP (AVSP CAG)** 

On August 12, 2020, the City Council approved an agreement for consultant services with RRM Design Group (RRM) to complete the Agoura Village Specific Plan (AVSP) Update. The scope of work included, among other things, a task to coordinate up to five (5) meetings with the AVSP Citizens Advisory Group (CAG).

The original plan was to have five total meetings, bi-monthly. However, more meetings are needed to ensure each planning principle is thoroughly discussed, so that comprehensive AVSP revisions can ultimately be recommended for the City Council's consideration.

With this in mind, staff and the CAG believe meetings should be held monthly, and are requesting seven (7) meetings be added to the schedule. RRM has agreed to provide the additional meetings at the same rate per meeting as the original contract.

The additional funding being requested is in the amount of \$26,880, an increase of 21.4% above the original contract of \$125,630. Section 4 of the contract agreement with RRM allows the City Manager to approve additional work up to 10% of the original agreement. Any amount exceeding 10% must be approved by the City Council.

If approved, no additional General Funds would be needed in the current fiscal year 2020-21, and meetings occurring after July 1, 2021 will be accounted for in the proposed FY 2021-22 budget.

#### RECOMMENDATION

Staff respectfully recommends the City Council approve the First Amendment to the Agreement for Consultant Services with RRM Design Group in the amount of \$26,880, for seven (7) additional meetings of the Agoura Village Specific Plan Citizens Advisory Group (AVSP CAG).

## FIRST AMENDMENT TO AGREEMENT BETWEEN CITY OF AGOURA HILLS AND RRM DESIGN GROUP

#### AGOURA VILLAGE SPECIFIC PLAN UPDATE

THIS FIRST AMENDMENT is made and entered into as of May 13, 2021, by and between the City of Agoura Hills, a municipal corporation (hereinafter referred to as "City"), and RRM DESIGN GROUP (hereinafter referred to as "Consultant"). In consideration of the mutual covenants and conditions set forth herein, the parties agree as follows:

- 1. This Amendment is made with the respect to the following facts and purposes:
- a. On August 12, 2020, the City and Consultant entered into that certain Agreement entitled "Agreement for Consultant Services", in the amount of (\$125,630), One Hundred Twenty Five Thousand Six Hundred Thirty Dollars and Zero Cents.
- b. On May 13, 2021, the City and Consultant entered into the First Amendment to that certain Agreement entitled "Agreement for Consultant Services," to add scope of work and increase the payment in the amount of (\$26,880), Twenty Six Thousand Eight Hundred Eighty Dollars and Zero Cents.
- 2. Section 4 of the Agreement entitled "**PAYMENT**" at paragraph "a" is hereby amended to read as follows:

"The City agrees to pay Consultant monthly, in accordance with the payment rates and schedules and terms set forth in Exhibit B, Payment Rates and Schedule, attached hereto and incorporated herein by this reference as though set forth in full, based upon actual time spent on the above tasks. Any terms in Exhibit B, other than the payment rates and schedule of payment, are null and void. The FIRST Amendment amount shall not exceed \$26,880, for additional Agoura Village Specific Plan Citizen's Advisory Group (CAG) Meetings for a total Agreement amount of (\$152,510), for a total of One Hundred Fifty Two Thousand Five Hundred Ten Dollars and Zero Cents (\$152,510)."

- 3. Exhibit "A" to the Agreement is hereby amended by adding thereto the items set forth on Attachment "A" to this Amendment, which is attached hereto and incorporated herein as though set forth in full.
- 4. Except for the changes specifically set forth herein, all other terms and conditions of the Agreement shall remain in full force and effect.
