Dear Mayor Denis Weber and Honorable City Council:

SOS respectfully requests that the City Council continue the scheduled May 12 Linear Park hearing until an alternative is reviewed which Restores Chesebro Creek as mandated in our adopted General Plan for the AVSP. Please inform us by Friday, if the MND Linear Park at this location has been removed from the May 12 agenda.

In meeting with a watershed person at the site, we believe that it is feasible to restore Chesebro Creek at this location. One of the suggested designs would greatly benefit landowner Whizzins complimenting his already existing outdoor dining establishments with "creekside dining".

Fiscally, a project which is a true creek naturalization watershed project would easily qualify for any amount of multi-millions of dollars from our state billion dollar watershed bond .. We might help get from Heal the Bay and other Malibu Creek Watershed organizations to support it.

Las Virgenes Water District needs to renovate its pump station within this project. The multi-million dollar watershed grant could also help cover these costs for our Water District.

The fact is that there are completed naturalization projects which are the width as seen here at this location. We request that your consultant CWE explore an alternative/s here which "Restores Chesebro Creek" as it is feasible.

We have drawn up a design of one possible restoration design: 1) loop trailway 2)creek ultimately restored in two parts 3) a walk over bridge put in front of LV pump station with the cement culver remaining underneath 3) small play park area in the widest portion which already appears to having plantings of native grasses and irrigation.
