To provide public comment live at the

meeting, access the meeting remotely via Zoom (refer to the link located on the agenda). To request to speak during public comment, please click the "Raise Hand" button on the Zoom toolbar. Speaker must be present when called to speak; staff will announce the speaker's name, as listed on Zoom, and unmute the microphone to speak (audio only). Prior to speaking, state first and last name and provide city of residence for the record. Public testimony is limited to three (3) minutes per speaker.

The Planning Commission staff report will be available for review at City Hall at the above address and online at <u>agourahillscity.org</u> by July 12, 2021.
