

**RESOLUTION NO. 05-1375**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF AGOURA HILLS, CALIFORNIA, AMENDING THE COMPENSATION PLAN; SETTING SALARY RANGES FOR CITY EMPLOYEES EFFECTIVE JULY 1, 2005; ELIMINATING THE CLASSIFICATIONS OF BUILDING INSPECTOR I, BUILDING INSPECTOR II, CODE COMPLIANCE OFFICER, FACILITIES/OPERATION SUPERVISOR, FINANCE OFFICER, PARKS/PUBLIC WORKS INSPECTOR, PRINCIPAL PLANNER, PUBLIC WORKS INSPECTOR, RECREATION SUPERVISOR, TEEN PROGRAM COORDINATOR, TENNIS INSTRUCTOR I, AND TENNIS INSTRUCTOR II; ESTABLISHING THE CLASSIFICATIONS OF ASSISTANT DIRECTOR OF COMMUNITY DEVELOPMENT, DIRECTOR OF FINANCE, FACILITIES/ OPERATION SUPERVISOR II, PUBLIC WORKS INSPECTOR II, SENIOR BUILDING INSPECTOR, AND SENIOR PLANNER; APPROVING AND SETTING THE SALARY RANGE FOR THE CLASSIFICATIONS**

**THE CITY COUNCIL OF THE CITY OF AGOURA HILLS HEREBY FINDS, RESOLVES, AND ORDERS AS FOLLOWS:**
