Honorable Mayor Weber and City Council Members:

These comments are submitted on behalf of Save Open Space, Santa Monica Mountains (SOS) supporting the Planning Commission's decision/staff recommendation to deny project approval.

The applicant has presented an argument which defies common sense and planning law. It asks you to approve this project even though it has not yet undergone environmental review as required by CEQA in arguing that the project's violations of City policies, including those adopted for the Agoura Village Specific Plan, should be ignored. Even if this argument is valid, which it is not, the remedy is to **not grant any approvals, but simply refer the project back to planning to prepare a detailed analysis of all issues in a draft EIR as mandated by CEQA.**

Before this Council determines if there has been compliance with Agoura's General Plan and the Village Area Plan as well as CEQA, the public has the right to weigh in on this project and all of these issues after full analysis of the facts. The vehicle for enabling valid consideration and public participation in this process is a duly circulated draft environmental impact report.

At this juncture, it is certainly premature to grant any approvals. Denial of the project as currently presented is appropriate for all the reasons stated in the staff report. SOS and the many Agoura residents it represents intend to present information regarding the project's noncompliance with City environmental standards, including but not limited to traffic and housing impacts, as well as other inconsistencies with the General and Specific Plans when the draft EIR is shared with the public.

We thank you for considering our comments and request all council members to deny applicant's appeal.
