1. Approve Minutes of the August 19, 2021, Regular Planning Commission Meeting

DISCUSSION ITEM

2. Public Scoping Meeting to Receive Public Comments for Notice of Preparation of a Subsequent Program Environmental Impact Report for the City of Agoura Hills General Plan Housing, Land Use, Safety, and Circulation Elements Update

Assistant City Attorney Nick Ghirelli made the following announcement to set the tone for the meeting: "This agenda item is a scoping meeting under CEQA for the EIR that is going to be prepared in conjunction with the General Plan Update. The purpose of a scoping meeting is to get very early feedback from public agencies and the public on what they would like to see analyzed and considered as part of the environmental review of the forthcoming project that is going to be analyzed and that is the General Plan Update. The purpose of doing it so early in advance, even before the General Plan has actually been fully developed, is to get a sense of what those issues are that the public would like to see addressed in the EIR and to offer thoughts on what should be in the General Plan to be analyzed, alternatives that should be considered (for example, analyze maybe a less dense development in certain areas of the City versus more dense development), consider mitigation measures and consider impacts (like traffic, biological impacts, impacts to habitat) and what that scope of analysis should look like. Right now, the General Plan is not before you so we're not taking comment on the General Plan. To be clear, there is going to be many more opportunities to comment on, not just the EIR, but the General Plan. Once the EIR is completed and the General Plan is completed, that EIR will be circulated for public comment, that will be a 45-day comment period, and at that point public agencies and the public will have an opportunity to comment on the EIR and the General Plan at that time. And, then, once those comments have been responded to, the General Plan and the EIR will come before the Planning Commission where there will be a public hearing and a recommendation will be made by the Planning Commission. And, then, there will be another public hearing before the City Council before it is adopted, modified, or not adopted. This is just the first step in a very long process and so we're not necessarily looking for great detail about what the General Plan is going to look like, but we're looking for thoughts on the scope of environmental review that should be conducted by the City in conjunction with the General Plan."
