SUBJECT: AUTHORIZE PURCHASE OF VERY SMALL APERTURE TERMINAL (VSAT) EQUIPMENT FROM MACKAY COMMUNICATION INC. - SANTA MONICA MOUNTAINS CONSERVANCY EMERGENCY OPERATIONS

WILDFIRE RESILENCY GRANT

In April of 2021, the City of Agoura Hills was awarded an Emergency Operations Wildfire Resiliency grant from the Santa Monica Mountain Conservancy (SMMC) to use toward assisting the City with its fire resiliency efforts. Of several elements approved for grant funding, the purchase of Very Small Aperture Terminal (VSAT) equipment to assist with its continuing efforts to enhance communication was included. VSAT technology affords the City the ability to communicate via satellite technology in the event all other forms of the communication network fail (i.e., down phone and internet systems, etc.).

VSAT technology will allow the City to be mobile in the event the City's emergency operation center must be vacated, and relocated to another location while still affording it the ability to continue to establish communications with other respective response agencies. The VSAT equipment is portable, and can be mounted a vehicle or left stationary on the ground. The proposal also includes an additional year of Mobile Emergency Response services (air time) for the VSAT equipment.

City staff prepared a Request for Qualification/Request for Proposal bid package to solicit proposals from respective companies specializing in VSAT technology. The bid package was released in December 2021 via the City's electronic bid process, and the City received two prospective bidders for this RFQ/RFP:

Staff reviewed the proposal submitted and concluded that MacKay Communications was responsive to the request and best met the needs for the City. Additionally, the City has utilized MacKay Communications in the past for other communication equipment and their staff is thoroughly knowledgeable, responsive and available for assistance with inquires. inquires. It should be noted that while the second proposer did provide a bid, the package was absent of other requested information.

The funding for this equipment is available via the SMMC Emergency Operations Wildfire Grant as an approved expenditure, but will require the City Council's authorization for additional budgetary funding to purchase the equipment that will be reimbursed from the grant via a payment request.

Should the City Council authorize the purchase, staff will begin the coordination of work needed to commence the purchase. It should be noted per the MacKay Communications, lead time for receipt of the equipment will be 2-3 months as a result of supply chain challenges.

RECOMMENDATION

Staff respectfully recommends the City Council authorize the purchase of the Very Small Aperture Terminal (VSAT) equipment from Mackay Communications Inc., in the amount of \$45,784.95, and appropriate \$45,784.95 from the Fund 260, Fire Grant.
