Upon presentation of the staff report, the Mayor opened the floor for public comment.

ACTION: Following a question and answer period, the motion by Councilmember

Schwarz to read, by title only, and adopt urgency <u>Ordinance No. 06-338U</u>, was seconded by Councilmember Edelston, and approved on a roll

call vote of 5-0.

ACTION: Following discussion, the motion by Councilmember Schwarz to

introduce, read by title only, and waive further reading of <u>Ordinance No.</u> **06-338** was seconded by Councilmember Edelston, and approved on a roll

call vote of 5-0.

City Attorney Steele noted that the action this evening is in effect for 45 days only and, within that 45-day period, the City Council will hold a noticed Public Hearing to take further testimony and have further discussion about the issue.

#### **COUNCIL, STAFF COMMENTS**

City Engineer Ken Berkman spoke about the completion and opening of the northbound offramp of the U.S. 101/Kanan Road Interchange Project, and reported that the Engineering Department had received a community assistance visit from the Federal Emergency Management Agency (FEMA) and the audit of the City's floodplain ordinances and policies ended in a positive result. Councilmember Edelston spoke about the Day Fire; reported that the Daniel Freeman Memorial Hospital (Inglewood) closed its emergency room and Martin Luther King Hospital (Los Angeles) did not pass its certification and, although not in our community, these actions would cause compression in the Emergency Medical Service (EMS) system and impact everyone in the area; and, noted that, as a result of claims filed for several events that were canceled due to the fires last year, the Agoura Hills/Calabasas Community Center would be recovering funds from their lost revenues.

Mayor Weber spoke about Reyes Adobe Days and requested the City Council adjourn in memory of Agoura Hills resident Ken Horton, who passed away last week.
